### 4. Disclosure of Information:

We do not share, sell or rent your e-mail, postal address, or any other data we hold about you to any third party, unless a prior consent is obtained from you. We may however disclose your personal information as and when required under law, in cases where it is obligatory to do so. The transaction information of the registered users is saved to pay you the cashback and keep you updated about the new policies and best deals we currently offer.

We make good faith efforts to provide you access to your personal information upon request and to let you correct such data if it is inaccurate and delete it, when reasonably possible.
